

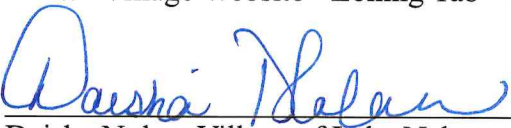

A public hearing will be held by the Village of Lake Nebagamon Zoning Commission September 30, 2026 in the Lower Level of the Village Auditorium, at 11596 E Waterfront Drive Lake Nebagamon, WI 54849. The hearing will begin at 6:00 pm to consider the following matter:

VILLAGE OF LAKE NEBAGAMON FLOODPLAIN PROTECTION ZONING ORDINANCE

The Zoning Commission proposes to rescind the existing Village of Lake Nebagamon Floodplain Zoning Ordinance 2012, and to adopt a new Village of Lake Nebagamon Floodplain Ordinance entitled Lake Nebagamon Floodplain Ordinance 2026.

The proposed ordinance is required for village adoption by state law. The proposed regulations are intended to protect life, health, and property in floodplain areas and will govern uses permitted in mapped floodplains.

The proposed ordinance and maps are available for viewing in the municipal office located in the lower level of the Village Auditorium during normal business hours, and may also be found on the department website at the following link: www.villagelakenebagamon.gov
